A RESOLUTION TO REQUEST THE TENNESSEE STATE SENATE AND TENNESSEE HOUSE OF REPRESENTATIVES TO AMEND SB1719 AND HB2137 TO INCLUDE FULL-TIME EMERGENCY MEDICAL SERVICES PERSONNEL

WHEREAS, SB1719 and HB2137 says “Under this bill, every child in this state under 24 years of age whose parent is employed as a full-time law enforcement officer or full-time firefighter in this state shall receive a 25 percent discount on tuition to any state-operated institution of higher learning. Any child who is receiving the discount provided for by this bill but whose parent dies during the time the child is enrolled and receiving the discount will be able to continue to receive the discount. This bill specifies that any reimbursements to a state-operated institution of higher learning for the tuition discounts provided by this bill will be limited to those funds specifically appropriated for that purpose in the general appropriations act. Reimbursement will be limited to providing for the discount on tuition provide for in this bill;” and

WHEREAS, Emergency Medical Services personnel work in and under the same situations and are part of the emergency services also and should receive the same benefits as other emergency personnel who work in and under the same situations; and,

WHEREAS, Franklin County recognizes the need and respects the work that all emergency service personnel do.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Franklin County, Tennessee, meeting in its regular session on this _____ day of _____, 2016 that the Board of County Commissioners of Franklin County does ask the Tennessee State Senate and House of Representatives to amend SB1719 and GB2137 to include full-time Emergency Medical Services personnel.
